Service Provider of the Year: Child Care Resources of Rockland, Inc. Child Care Resources of Rockland is the agency in Rockland County that helps the child care businesses get started, remain valuable and improve quality. They educate the workforce, counsel families on best options for their children and advocate for funding. They are the only agency of its kind in Rockland County.

PTAC Hall of Fame: OC Lugo Co. Inc. Awarded the First REDC Procurement Technical Assistance Center Hall of Fame Award, OC Lugo Co. Inc. has been a client since 1989 and has become the conduit between a global network of top chemical suppliers, North American clients and US government agencies, manufacturing emergency oxygen systems;

The guest speaker was Dan Adams, Executive Chairman of Protein Sciences Corp. Protein Sciences is a leader in developing and manufacturing vaccines, therapeutics and diagnostics. Dan spoke about the lead vaccine, Flublok, a patented, first in class recombinant influenza vaccine which received licensure from the FDA in January 2013 manufactured at their site in Rockland County.
